	I am aware that such service could require that I be in attendance 20-25 hours per week. In this regard, I understand that as a grand juror I must be flexible and able to serve some evening and weekend hours, as well as working during normal business hours. I understand that it is essential that all Grand Jury members be in attendance at all meetings, and only the most pressing emergency or my illness would be reasons for absence. I declare, pursuant to Penal Code §896(a), that I will be available to serve during those required hours.
